The Maturity Date of the product is 09.04.2029, unless an Early Redemption Event occurs as specified below.

#### **OBJECTIVES**

The objective of the product is to provide additional return in exchange for the risk of loss of capital.

#### Underlying

AIRBUS SE (ISIN: NL0000235190), LEONARDO S.P.A. (ISIN: IT0003856405) and RHEINMETALL AG (ISIN: DE0007030009) Shares.

#### How the return is determined

- Reference Value of the Underlying: on each Early Redemption Valuation Date and on each Digital Valuation Date, the value of each Underlying will be equal to the (i) reference price (LEONARDO S.P.A. Share) and (ii) closing price (AIRBUS SE and RHEINMETALL AG Shares) on such date.
- Early Redemption (autocallability): the product provides the possibility of an automatic Early Redemption (autocallability) if the Reference Value of the Underlying with the worst performance on an Early Redemption Valuation Date is higher than or equal to the relevant Early Redemption Level (i.e. Early Redemption Event). In this case, the product will be automatically redeemed and the investor will receive, on the relevant Early Payment Date, the Early Redemption Amount equal to EUR 100.00. ## Adjustments

The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because the Issuer is not able to pay you. The Issuer has classified this product as 4 out of 7, which is a medium risk class. This classification results from two elements: an estimation of the market risk that rates the potential losses from future performance at a medium level, and an estimation of the credit risk, according to which poor market conditions are unlikely to impact the capacity of the Issuer to pay you. You are entitled to receive back at least 3.24% of the Issue Price. Any amount over this, and any additional return, depends on future market performance and is uncertain. However, this protection against future market performance will not apply if you cash in before 09.04.2029. If the Issuer is not able to pay you what is owed, you could lose your entire investment.
