# **OBJECTIVES**

The objective of the product is to provide additional return in exchange for the risk of loss of capital.

### How the return is determined

- o If the Underlying Final Value is higher than or equal to the Barrier Level: the investor will receive on the Settlement Date an amount equal to the Issue Price.
- o If the Underlying Final Value is lower than the Barrier Level: the investor will receive on the Settlement Date an amount linked to the Underlying Final Value.

Lower Risk

The risk indicator assumes you keep the product until 29.12.2023. The actual risk can vary significantly if you cash in at an early stage and you may get back less.

The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because the Issuer is not able to pay you. The Issuer has classified this product as 1 out of 7, which is the lowest risk class. This classification results from two elements: an estimation of the market risk that rates the potential losses from future performance at a very low level, and an estimation of the credit risk, according to which poor market conditions are very unlikely to impact the capacity of the Issuer to pay you. You are entitled to receive back at least 48.12% of the Issue Price. Any amount over this, and any additional return, depends on future market performance and is uncertain.
