WHAT IS THIS PRODUCT?

TYPE

Equity Protection Investment Certificate

TERM

The Maturity Date of the product is 31.01.2028.

OBJECTIVES

The objectives of the product are to provide an exposure (with cap) to the performance of the Underlying and to protect part of the invested capital at maturity.

Underlying

ISTOXX® EUROPE 600 ESG-X NR DECREMENT 4.75% (EUR - PRICE) Index (ISIN: CH0454923092).

How the return is determined

- **Reference Value of the Underlying:** on the Digital Valuation Period, the value of the Underlying will be equal to the arithmetic mean of the daily closing levels of the Underlying on each date of such Digital Valuation Period
- **Settlement Amount at Expiry Date:** the amount at the Expiry Date will be determined as follows:
 - **If the Underlying Final Value is higher than or equal to the Barrier Level:** the investor will receive on the Settlement Date an amount equal to the higher of: (a) an amount equal to the Issue Price and (b) an amount linked to the Underlying Final Value. Such amount will not be higher than the Cap.
 - **If the Underlying Final Value is lower than the Barrier Level:** the investor will receive on the Settlement Date an amount linked to the Underlying Final Value, which will not be lower than the Protection.
- **Digital Amount:** the product provides for the payment of a Digital Amount if the Reference Value of the Underlying on the Digital Valuation Period is lower than the Digital Level. The Digital Amount is equal to EUR 200 and will be paid on the Digital Payment Date. Otherwise, if the Reference Value of the Underlying on the Digital Valuation Period is higher than or equal to the Digital Level, no Digital Amount will be paid on the Digital Payment Date.
- **Plus Amount:** the product provides the unconditional payment of a Plus Amount, which is not linked to the performance of the Underlying. The Plus Amount is equal to EUR 15.50 and will be paid on the Plus Payment Date.
- **Redemption Amount:** for each certificate the Redemption Amount at Expiry Date, equal to the sum of the Settlement Amount and the Digital Amount, will not be lower than EUR 900.

Adjustments

Therefore, the amounts receivable under the certificates may be affected by what the Issuer will undertake as a consequence of the events specified in the terms and conditions of the product.

INTENDED RETAIL INVESTOR

This investment is intended for investor who:

- has a good knowledge/experience of markets and financial products;
- has an investment horizon consistent with the maturity date of the product;
- is willing to afford a partial loss of the invested amount at the maturity date;
- wants to have the possibility to disinvest the product before its maturity date, although without any guarantees to get back the invested amount.

WHAT ARE THE RISKS AND WHAT COULD I GET IN RETURN?

The risk indicator assumes you keep the product until 31.01.2028. The actual risk can vary significantly if you cash in at an early stage and you may get back less.

The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because the Issuer is not able to pay you. The Issuer has classified this product as 3 out of 7, which is a medium-low risk class. This classification results from two elements: an estimation of the market risk that rates the potential losses from future performance at a medium-low level, and an estimation of the credit risk, according to which poor market conditions are unlikely to impact the capacity of the Issuer to pay you. You are entitled to receive back at least 90% of the Issue Price. Any amount over this, and any additional return, depends on future market performance and is uncertain. However, this protection against future market performance will not apply if you cash in before 31.01.2028. If the Issuer is not able to pay you what is owed, you could lose your entire investment.

PERFORMANCE SCENARIOS

What you will get from this product depends on future market performance. Market developments in the future are uncertain and cannot be accurately predicted. The scenarios shown are illustrations based on results from the past and on certain assumptions. Markets could develop very differently in the future.

The scenarios are shown in five hypotheses of market conditions at different holding periods of the product. The stress scenario shows what you might get back in extreme market circumstances. WHAT HAPPENS IF INTESA SANPAOLO S.P.A. IS UNABLE TO PAY OUT?

Cost over time

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest, how long you hold the product and how well the product does. We have assumed:

- In the first year you would get back the amount that you invested (0% annual return). For the other holding periods we have assumed the product performs as shown in the moderate scenario;
- EUR 10,000 is invested.
