WHAT IS THIS PRODUCT?

TYPE

Bonus Investment Certificate

TERM

The Maturity Date of the product is 13.09.2027.

OBJECTIVES

The objective of the product is to provide additional return (with cap) in exchange for the risk of loss of capital.

Underlying

STELLANTIS N.V. Share (ISIN: NL00150001Q9).

How the return is determined

- Settlement Amount at Expiry Date:** the amount at the Expiry Date will be determined as follows:

WHAT ARE THE RISKS AND WHAT COULD I GET IN RETURN?

The risk indicator assumes you keep the product until 13.09.2027. The actual risk can vary significantly if you cash in at an early stage and you may get back less.

The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because the Issuer is not able to pay you. The Issuer has classified this product as 6 out of 7, which is the second-highest risk class.

This classification results from two elements: an estimation of the market risk that rates the potential losses from future performance at a high level, and an estimation of the credit risk, according to which poor market conditions are unlikely to impact the capacity of the Issuer to pay you. You are entitled to receive back at least 11.6% of the Issue Price. Any amount over this, and any additional return, depends on future market performance and is uncertain. However, this protection against future market performance will not apply if you cash in before 13.09.2027. If the Issuer is not able to pay you what is owed, you could lose your entire investment.

PERFORMANCE SCENARIOS

What you will get from this product depends on future market performance. Market developments in the future are uncertain and cannot be accurately predicted. The scenarios shown are illustrations based on results from the past and on certain assumptions. Markets could develop very differently in the future.

The scenarios are shown in five hypotheses of market conditions at different holding periods of the product. The stress scenario shows what you might get back in extreme market circumstances. WHAT HAPPENS IF INTESA SANPAOLO S.P.A. IS UNABLE TO PAY OUT?

This product is not protected by any investor compensation or guarantee scheme. Cost over time
