### **OBJECTIVES**

The objectives of the product are to provide additional return and to protect the invested capital at maturity.

### Underlying

ISTOXX® EUROPE 600 ESG-X FINTECH TILTED NR DECREMENT 4.5% (EUR - PRICE) Index (ISIN: CH0149413640).

### How the return is determined

- Reference Value of the Underlying: on each Annual Valuation Date, the value of the Underlying will be equal to the closing level of the Underlying on such date.
- Settlement Amount at Expiry Date: the investor will receive on the Settlement Date an amount equal to the Issue Price.
- Internal Return Amount: the product provides for the payment of one or more Internal Return Amounts, determined on the relevant Annual Valuation Dates and payable on the relevant Annual Remuneration Payment Dates, linked to the performance of the Underlying. Such Internal Return Amount will be equal to the product of: (a) the Issue Price and (b) the difference between (i) the ratio of the Reference Value of the Underlying to the Underlying Initial Value and (ii) 1, such difference divided by N. Such Internal Return Amount will not be higher than 15% of the Issue Price. If the result is, on the relevant Annual Valuation Date, lower than or equal to zero, no Internal Return Amount will be paid. ### Adjustments

- wants to have the possibility to disinvest the product before its maturity date, although without any guarantees to get back the invested amount.

# WHAT ARE THE RISKS AND WHAT COULD I GET IN RETURN?





The risk indicator assumes you keep the product until 29.03.2030. The actual risk can vary significantly if you cash in at an early stage and you may get back less.

The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because the Issuer is not able to pay you. The Issuer has classified this product as 3 out of 7, which is a medium-low risk class. This classification results from two elements: an estimation of the market risk that rates the potential losses from future performance at a low level, and an estimation of the credit risk, according to which poor market conditions are unlikely to impact the capacity of the Issuer to pay you. You are entitled to receive back at least 100% of the Issue Price. Any amount over this, and any additional return, depends on future market performance and is uncertain. However, this protection against future market performance will not apply if you cash in before 29.03.2030. If the Issuer is not able to pay you what is owed, you could lose your entire investment.

The scenarios are shown in five hypotheses of market conditions at different holding periods of the product. The stress scenario shows what you might get back in extreme market circumstances.
