WHAT IS THIS PRODUCT?

TYPE

Equity Protection Investment Certificate

TERM

The Maturity Date of the product is 30.07.2032.

OBJECTIVES

The objectives of the product are to provide an exposure (with cap) to the performance of the Underlying and to protect the invested capital at maturity.

Underlying

EURO ISTOXX® 50 AEROSPACE & DEFENSE TILTED NR DECREMENT 5% (EUR - PRICE) Index (ISIN: CH1362050747).

How the return is determined

- **Reference Value of the Underlying:** on each Participation Valuation Date, the value of the Underlying will be equal to the closing level of the Underlying on such date.
- **Settlement Amount at Expiry Date:** the amount at the Expiry Date will be equal to the higher of: (a) an amount equal to the Issue Price and (b) an amount linked to the Underlying Final Value. Such amount will not be higher than the Cap.
- **Participation Remuneration Amount:** the product provides for the payment of one or more Participation Remuneration Amounts, determined on the relevant Participation Valuation Dates and payable on the relevant Participation Remuneration Payment Dates, linked to the performance of the Underlying. Such Participation Remuneration Amount will be equal to the product of: (a) the Issue Price and (b) 2.96% of the sum of 1 and the ratio between (i) the difference between the Reference Value of the Underlying and the Underlying Initial Value and (ii) the Underlying Initial Value, such ratio multiplied by 2. Adjustments

Therefore, the amounts receivable under the certificates may be affected by what the Issuer will undertake as a consequence of the events specified in the terms and conditions of the product.

INTENDED RETAIL INVESTOR

This investment is intended for investor who:

- has a medium knowledge/experience of markets and financial products;
- has an investment horizon consistent with the maturity date of the product;
- intends to obtain an amount at least equal to the nominal amount of the investment at the maturity date;
- wants to have the possibility to disinvest the product before its maturity date, although without any guarantees to get back the invested amount.

WHAT ARE THE RISKS AND WHAT COULD I GET IN RETURN?

The risk indicator assumes you keep the product until 30.07.2032. The actual risk can vary significantly if you cash in at an early stage and you may get back less.

The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because the Issuer is not able to pay you. The Issuer has classified this product as 3 out of 7, which is a medium-low risk class. This classification results from two elements: an estimation of the market risk that rates the potential losses from future performance at a low level, and an estimation of the credit risk, according to which poor market conditions are unlikely to impact the capacity of the Issuer to pay you. You are entitled to receive back at least 100% of the Issue Price. Any amount over this, and any additional return, depends on future market performance and is uncertain. However, this protection against future market performance will not apply if you cash in before 30.07.2032. If the Issuer is not able to pay you what is owed, you could lose your entire investment.

PERFORMANCE SCENARIOS

The scenarios are shown in five hypotheses of market conditions at different holding periods of the product. The stress scenario shows what you might get back in extreme market circumstances. Cost over time
